Aims:

- To provide practical insights into injectable therapy use in Type 2 Diabetes. This will include an overview of therapy indications and contraindications, advantages and disadvantages, positioning and initiation.
- The above will be achieved through interactive discussion and case study consideration.

- Better support patients already on insulin therapy in their practice, interpreting blood glucose profiles and advising on insulin adjustment.
- Coach patient self-management of their condition and treatment.

Clinical Outcomes:

- It is anticipated that gaining greater practical insight into injectable therapies will drive:
- Greater health professional understanding and confidence with injectable therapy use.
- Earlier injectable therapy initiation.
- Greater achievement of QOF outcomes for HbA1c control for injectable treated patients.
- Potential reduction of hypoglycaemia episodes by pre-emptive action.
- Greater patient empowerment and control over their condition.

Note: This session will provide guidance on management of the person already on insulin therapy but it is not intended as an Insulin Initiation Course. For that you will need to seek local support. However this event will provide significant insight into management of the insulin treated patient and insulin adjustment.
